## Medicare Part D Open Enrollment Available Now through December 31

The Open Enrollment Period for Medicare Part D is now through the end of December, and it's time for Medicare beneficiaries to begin reviewing their prescription drug coverage for 2011.

There have been a number of significant changes in the Medicare Part D landscape for next year, including:

- There will be 33 stand-alone prescription drug plans in 2011, down 35% from the 46 plans available this year.
- Among the plans no longer being offered is First Health Part D Secure which offered the least expensive monthly premium in 2010.
- Coventry AdvantraRX, which last year offered three popular plans, has pulled completely out of Oklahoma.

To bring Medicare beneficiaries up-to-date on all the changes for next year, IN-

COG Area Agency on Aging will be offering couseling sessions - in person & over the phone - through the end of the year. The counseling sessions offer beneficiaries free, unbiased help in comparing, selecting and enrolling in the plan that best fits their individual needs.

The 2011 Guide to Medicare Part D includes a review of the basics of Part D, details of all the Medicare Prescription Plans available in Oklahoma, a listing of all the Medicare Advantage health plans in Tulsa County, and information about the Extra Help available for beneficiaries with limited income and resources.

## FREE Legal Resources and Services Available

Legal Aid Services of Oklahoma provides free legal assistance for persons age 60 and over in Creek, Osage, and Tulsa Counties. Legal Aid lawyers answer questions by phone about legal issues facing older Americans. Common questions include whether a guardianship is necessary when you are taking care of grandchildren, how to deal with bill collectors, and whether you need a will. Other issues involve arranging for someone to

take care of your bills and deal with doctors if you get sick.

Lawyers are also available to draft basic legal documents, including powers of attorney, deeds, and living wills (advance directives). For help, call 918.428.4357 in Tulsa, or 1.800.534.5243.


