- b. Ozone Alert! Ms. Graham reported that the ozone season is not over as summer is not over. We have had a lot of rain, and there is no change from last month in our design value of 67 PPB. The standard is 70 so we are in compliance, but the value has been slowly going up over the last five years. The Clean Air Act indicates the EPA should revise or check out all five national standards to see if ozone levels should be raised, lowered or tightened in 2020. Oklahoma City also made it through
